**STIFEL AND KBW COMBINE FOR 13th CONSECUTIVE TOP 10 RANKING
IN STARMINE ANALYST AWARDS**

ST. LOUIS, July 10, 2019 — Stifel Financial Corp. (NYSE: SF) today announced that its Stifel, Nicolaus & Company, Incorporated (“Stifel”) and Keefe, Bruyette & Woods (“KBW”) subsidiaries combined to win 14 awards in the 2019 StarMine U.S. Analyst Awards from Refinitiv. This figure ranked sixth out of 151 qualifying firms, marking Stifel/KBW’s 13th consecutive top ten ranking. Stifel and KBW have won the second most awards of any firm over the last 15 years.

Stifel analysts won 11 awards, including No. 1 rankings in five individual categories. KBW won three awards, including one No. 1 ranking.

Stifel’s Simon Yarmak was recognized as the No. 9 overall earnings estimator, regardless of sector, out of 1,733 eligible analysts.

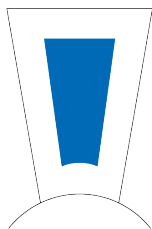
